1. What specific issues regarding Delta will you repeatedly bring to Ottawa's attention. Name what you feel is your top 2 most important issues for Deltans and explain why you feel these arethe most important issues. (3 min)

2. Looking back on the last few years, what could the federal government have done better, and what needs to be done immediately to correct this? Please name two things. (3min)

I understand the pandemic is an unprecedented event in which nobody knows what to do. We can only rely on the best available scientific evidence and clinicians' expertise to deal with the challenge.

In addition to the pandemic, there has been an effect on other health related crises; opioid overdose, mental health issues, cancer patients' treatment delay, PPE related medical waste contributing to environmental disasters.

This pandemic needs the collaboration of the whole community, to voluntarily follow public health guidelines and look after each other. This is the time we need to look out for each other and respond to those who need support.

I strongly believe in the importance of disease prevention and public health promotion.

The devastation and non-stop outbreaks of Covid 19 in senior-care facilities and health care facilities is highly possibly related to the issue of short supply of health care workers. This has been a big issue in the past, but the pandemic has amplified the deadly impact of short staffing. It is a wakeup call for all of us to think about how we can plan better for now and the future.

3. What are your concerns, if any, do you have about the George Massey Replacement project?

I'm in favour of the tunnel replacement, as long as there's limited negative impact on the environment. I prefer to have a bridge because I'm worried about rising sea level concerns in the future due to extreme weather, increasing potential risk of flooding. Project to another 20 years in the future. 4. What is your position on Roberts Bank Terminal 2? An environmental assessment panel concluded that RBT2 would result in significant adverse and cumulative effects including to fish and fish habitats, Dungeness crab, juvenile chinook, South Resident Killer whales, biofilm, migratory birds, and other species at risk. Furthermore it concluded that there would be significant adverse effects on cultural heritage for the Tsawwassen and Tsleil-Wauthuth First Nations.

Environment is one major factor of social determinants of health. From a nursing perspective, we should protect the environment.

I share my delta residents' concerns and passion to protect the environment. I had been following the project closely until the public hearing in 2019. Due to the COVID pandemic, I have prioritized my focus on health care and senior care.
